• The Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) provides supplemental foods, health care referrals, and nutrition education for low-income pregnant, breastfeeding, and non-breastfeeding postpartum women, and to infants and children up to age 5 who are found to be at nutritional risk. *Including grandparents raising grandchildren because the children are at risk*.

- Temporary Assistance for Needy Families. Children being raised by Kin Caregivers, who have not adopted the child, qualify without consideration of the Kin Caregivers income, and after calculating any Social Security or child support the child is receiving.
- Apply for Child Only TANF Best option is to apply in person at the "DHS" Department of Human Services County Benefits Office. Have the application time stamped and put "Child Only TANF" in all of the borders of the application. If denied you can appeal and ask why it was denied. Make sure that the application was processed as "Child Only TANF".
- You will be asked to provide information about the parents of the child(ren) so that they may seek child support from the parent. If DHS is successful in collecting Child Support, it may go back to the County to pay for TANF funds paid out to the child. There are some rules to how much child support can affect the amount you receive. Be sure to ask the technician to explain this to you.

#### **Free and Reduced Lunches**

• All children in Colorado now receive free lunches. Children with low income should apply for Free and Reduced Lunch Program which can also cover the cost of certain school fees.

Children being raised in grandfamily & kinship without child welfare involvement may be considered "unaccompanied" can also qualify under the federal McKinney Vento Act.
